



RE: Petrifilm® Product Range- Hazard Classification

Valued Customer,

Petrifilm® products supplied by Neogen Corporation do not meet hazard classification criteria under the globally harmonized system for classification (GHS) and as such are exempt from Safety Datasheet (SDS) or Hazard Communication requirements globally. This article letter is being sent in lieu of a Safety Datasheet.

Non-hazardous articles are exempt from GHS classification as per UN Globally Harmonized System of Classification and Labelling of Chemicals, Revision 8, Section 1.3.2.1.1

United States

European Union

Australia

Petrifilm products meet the definition of article as defined by Safe Work Australia: Classifying hazardous Chemicals; National Guide (July 2020).
